Provided you have successfully completed Cert IV and the Diploma, you are entitled to apply to complete the Advanced Certification Program in Commercial and Asset Finance, with the ultimate goal to apply for Certification as a Finance Broker in Australia.

To meet the requirements necessary to be approved by the CFMIA Education Committee to hold the Certification status, you must meet the requirements of Section 5.2 of the "Rules Governing use of Certification", provided on the CFMIA website.

It is important that you read this information so that you may make an informed decision before undertaking the Advanced Certification Program in Commercial and Asset Finance.

Provided you have read and understood the requirements for approval under Section 5.2, you are welcome to present this application via email to the CFMIA administration team for consideration.

Once this application has been received, assessed, and approved, the CFMIA administration team will send:

- \cdot A letter of acceptance to you
- \cdot A member number
- \cdot An invoice which covers the complete cost of the course

• Links to the course conveners who will provide you the documentation, materials and support information readying you for commencement.

The cost of the course will be \$1,150.00 (GST inclusive).

This covers "Component A" of the course with "Accendo", the course provider approved by the CFMIA board, and "Component B" of the course with the Registered Training Organizations nominated by the board at the time of application to administer this component of the program.

You may choose the RTO you wish to use for the program.

Accendo and the nominated RTO will receive details from us of your application and connect with you to register you into their courses and inform you of the dates involved in their tutorials as well as the dates as of which you must complete their courses.

A part of "Component A" will require you to take part in webinars and you will be instructed as to the dates and times these will be conducted.

On successful completion of these courses, and thus the total program (on the proviso that you have completed Cert IV and the Diploma), you may then make application to the CFMIA Education Committee for Certification status as a Broker in the Australian Finance Industry.
